- **5.** Any delay in delivery of the vehicle for conversion causes the necessity to set a new date of conversion by Carlex Design Limited.
- **6.** Upon completing the conversion by Carlex Design Limited and crediting the full payment at the Carlex Design Limited bank account, the vehicle shall be made available to the Commissioning Party.
- **7.** The Commissioning Party acknowledges that during the disassembly of original parts, they may be scratched or damaged, and declares that he/she will not lodge any complaints to Carlex Design Limited pertaining thereto.
